President Jay Wood called the meeting called to order at 7:00 p.m.

#### **Public Comment**

➤ Scott Schoengarth from Entertainment Explosion shared that the 10<sup>th</sup> annual Really Big Shoe is scheduled for February 21, 2016. The proceeds from the concert are distributed among local school districts and Community Youth Services. Over the past nine years, they have donated over \$212,000 to help needy youth in Thurston County.

## **Student Reports**

▶ Bo Peradotto – BHHS: A food drive started November 2<sup>nd</sup> and will run through the 23<sup>rd</sup>. A new program was started – the Student Incentives Program – where students receive incentive cards based on their GPA range and then are able to use them for perks. Each year, every grade-level has a mural that gets repainted. Some students have put in 66+ hours of service, and the results are quite impressive. BHHS has a Math Center open every Tuesday and Thursday after school (Bo is one of the tutors). There is going to be a staff-led assembly on November 20<sup>th</sup>. DECA Marketing Summit is being held on November 17<sup>th</sup> and then students will go to the Western Regional Leadership Conference later this month. BHHS choir is having a rummage and bake sale at TMS to help raise funds for a trip to perform at Carnegie Hall. Girls' soccer, football, and swimming are all moving on to state-level competition. The Wolf Country Holiday Bazaar will be on November 14<sup>th</sup> to support ASB. Perception Day will be on November 19<sup>th</sup>.

➢ Jayson Haury – THS: Leadership Team seniors put together a theme of what they want to be remembered by – theme – become like a bird, expand your wing, try new things and fly like a bird. Volleyball starts state tournament as number 1 seed. Cross Country finished state competition last weekend. Football playoffs start tomorrow. In tennis singles – Ty Gentry placed first. There is a Dance and Drill competition on Saturday. Winter sports start next week. There was a Veterans Day assembly held this past Tuesday. Jayson felt it was the most powerful one ever. THS senior, Easton Trakel, has an older brother in the Army. He spoke at the assembly about his experiences. There was also had a gold star presentation to Coach Weeks whose father died in the Vietnam War.

# Superintendent's Report

- CCSS/Literacy: Roz Thompson started with a definition of literacy the ability to read and write; competence or knowledge in a specified area. There are four areas of the Smarter Balanced assessment reading, writing, speaking & listening, and research/inquiry. Kindergarten-6 Wonders is in year two and is going smoothly. Online support is provided by technology TOSA Tina Schmidt. Kelly Neely and the instructional facilitators organized a New Teacher Bootcamp last August. Tumwater U provided grade level updates. Grade Band professional development is given in after-school meetings 3 times during the year. Continued ongoing professional development, support, and resources through instructional facilitators are provided at each site. A revision of common formative assessments to reflect SBA item types is in process. In grades 6-12, secondary literacy TOSA Christa Williamson, held an ELA retreat in August to prepare an ELA vision and vertical alignment. ELA adoption 9-12 is in process.
- Superintendent's Remarks: Staff members are preparing a safety presentation for the board to include Chuck Liska, SRO. John announced that BHHS PE Teacher Lisa Summers was recently recognized by Evergreen State College after being nominated by a former student. Tammie Jensen-Tabor shared that B-3 Teacher Tammy Johnson was nominated for an Angel Award. Will be honored next week for her nomination. Kim Reykdal was selected as a finalist for the National Counselor of the Year. Tomorrow the Governor's wife, Trudi Inslee, will be visiting our district as part of a six-district visit to see community partnerships at work in schools. Poverty, community partners for before/after schools supports, and mental health will be the topics. We will share what we are doing, successes, as well as challenges and unmet needs. This morning John attended regional superintendents with the Thurston County Chamber to present levy/bond information. There are several levy presentations coming up. Middle school planning continues and an architect has been selected. Teams are being formed in that effort. John is continuing to attend staff meetings at each site. He commended the student representatives to the board and thanked them for being well prepared and representing the students of their schools so well.
